GOLDSBORO MUNICIPAL GOLF COURSE OPERATING POLICY**

GOLF COURSE RULES:

1. Proper attire will be required by all players at all times; shirt with a collar, no cut-offs allowed
2. Metal spikes are not allowed
3. Groups containing 5 players allowed only with permission from pro shop
4. All players must have clubs
5. All players must observe cart path rule of the day. Carts must stay on path on all par 3's and on hole number 3.
6. Do not drive carts past exit posts (brown post with white top)
7. Members and guests must have a valid drivers license to operate golf carts
8. Carts must be returned by posted times
9. All players must sign in at the pro shop prior to beginning play
10. Observe golf etiquette, maintain pace of play, allow faster players to play through, repair ball marks and divots, rake bunkers, etc.
11. Players age 12 and under must be accompanied by an adult 18 years or older
12. Walking allowed on weekends and holidays. Check with pro shop for available times
13. Upon completion of 18 holes of play, players must surrender golf carts should other players be waiting for carts to begin play
14. Tee times required for weekend and holiday play and can be made one week in advance
15. No private coolers allowed
16. No Glass Bottles Allowed
17. No refunds
18. Individuals failing to observe golf course rules may be required to leave the premises and may be refused future playing privileges on the Goldsboro Municipal Golf Course

OPERATING SCHEDULE

1. The Goldsboro Municipal Golf Course will be open every day, weather permitting, except Christmas and Thanksgiving Day
2. Hours of operation will be 7:00am until approximately 30 minutes before sunset

FEES AND DUES

1. All green fees, cart fees, range fees, etc. of the Goldsboro Municipal Golf Course have been established by the Goldsboro City Council and will be administered in full to all users of the Goldsboro Municipal Golf Course

BILLING

Members of the Goldsboro Municipal Golf Course will be billed approximate 30 days before the beginning of each quarters due date which is the 1st of the month. First quarter dues are due on January 1st; Second quarter dues are due on April 1st, Third quarter dues are due on July 1st, Fourth quarter dues are due on October 1st. Dues that are not paid by the 15th will be assessed a \$10.00 late fee. I understand that should any payment, including any applied late fees, not be received by the Parks and Recreation Department within 30 days after the due date (Jan. 1, April 1, July 1, Oct. 1), I may forfeit membership privileges, and all quarterly dues which I may have previously paid. I may also be ineligible for reinstating my membership for one (1) year from date of said forfeiture.

REMOVAL FROM MEMBERSHIP

1. Individuals will be removed from membership for non-payment of fees, failure to follow golf course rules and regulations, and for improper behavior.
